Please take the following steps to submit your written and/or oral presentation for the SCJAS Annual Meeting. It is the responsibility of the author(s) to accurately complete all required information or forms. Any omissions/illegibility may result in disqualification.

## Submission Agreement

By submitting a written and/or oral presentation, I grant the South Carolina Junior Academy of Science and *The Furman University Scholar Exchange (FUSE)* a perpetual, non-exclusive, world-wide, royalty-free License to distribute, publish, or copy this Submission. The Contributor retains copyright and other intellectual property rights to the Submission. The Contributor may revoke this non-exclusive License by sending an e-mail to [scholarexchange@furman.edu](mailto:scholarexchange@furman.edu). Upon receipt of the e-mail, the submission will be removed from FUSE within 90 days.

### I specifically acknowledge that:

1. I accept full responsibility for the contents of this abstract and research paper;
2. This submission contains original research that was carried out by myself (or my group if submitting as a group);
3. I have paid (or intend to pay) my current SCJAS membership dues (\$10) and the meeting registration fee (\$25);
